## PNG INVESTMENT WEEK GOLF CHALLENGE SPONSORSHIP TERMS & CONDITIONS

### 1. Golf Sponsorship Packages

All sponsorships are stated in AUD currency. PNG CORE reserves the right to alter and revise packages. PNG CORE is responsible for benefits stated in each package, anything additional or requested by the sponsor will be charged at cost to the sponsor. Sponsors will be included in promotional materials when full payments are settled. Your sponsorship will be confirmed after the funds are cleared in the PNG CORE bank account. Sponsors will also need to forward a brief abstract of your company profile and your logo in high-definition EPS, JPEG or TIFF to PNG CORE contact.

### 2. Goods and Services Tax (GST)

A 10% GST will be applied on all sponsorship stated, consistent with Australian Tax Laws.

### 3. Conditions of Payments

The sponsorship application form must be completed and submitted to PNG CORE. PNG CORE will provide the link for you to formally register online and receive the invoice accordingly. Full payment must be received as stated on the invoice. No partial payments will be accepted. The amount stated on the invoice does not include Bank charges that may be applied by the bank to process the transaction. Additional charges are the full responsibility of the payer. An application will be considered incomplete if the invoice issued is not settled in full. All promotional benefits will apply after the full payment, as stated in the invoice, is received.

### 4. Payment Methods

Please make all payments to the account provided on the invoice, referencing the invoice number issued by PNG CORE. Payments can be made via Electronic Funds Transfer (EFT), Bank Transfer, or Credit Card (Online). EFTPOS payment is also accepted at the PNG CORE office. We do not accept cheques or cash at the PNG CORE Office. For bank transfers, please ensure payment is in Australian dollars and include your company name and invoice number in the description/narration section. Bank cheques should be deposited directly into PNG CORE's bank account, and a copy of the remittance advice should be emailed to PNG CORE.

### 5. Cancellation

Cancellation of sponsorship must be made in writing to PNG CORE specifying the reason. The cancellation request is subject to the approval of PNG CORE taking into consideration the promotional benefits received and if the sponsorship can be resold. This policy will be reviewed should an unexpected change occur due to Government measures taken during the COVID-19 pandemic.

Note:

- i. 50% of the sponsorship amount as stated in the invoice will be retained for cancellations made on or before 25th November 2024.
- ii. 100% of the sponsorship amount as stated in the invoice will be retained for cancellations made on or after 25th November 2024.

### 6. Obligation and Rights
